1. Situation

1.1. This report provides the Audit Committee with details of the Single Tender Actions (STA) and Single Quotation Actions (SQA) approved by the Health Board for the period July to December 2017. The report also provides trend information on the number and value of STA's and SQA's details of regular STA's and SQA's and examples of STA's and SQA's deferred and the reasons for the deferrals.

2. STA and SQA Analysis

2.1. The details of the STA's and SQA's approved are attached as **Appendix A** to this report. Document. The table below identifies the number of STA's and SQA's received for the financial year to date, which shows a reduction in the numbers when compared to the 2016/17 financial year.

3. Regular STA and SQA Requests

3.1. There are a small number of SQA and STA requests received on an annual or bi-annual basis which is linked to the fact that there may only be a single supplier who can provide the equipment or service. These are regularly reviewed and as identified in the table below where possible SLA's have been put in place to remove the STA/SQA requirement.

4. STA/SQA'S deferred or added value

4.1. As part of the STA/SQA review process, the Procurement Department will seek where required to defer SQA's/STA's if they area not deemed appropriate or to secure added value. The following paragraphs give examples of where this has occurred.

STA received for Personal Child Health Record Books, Procurement investigated further and discovered a formal contractual arrangement, STA cancelled.

Purchase of Case Note Folders with Icom Ltd, Procurement renegotiated the price to below the £5K threshold – SQA cancelled.

Infant view Laryngo device – SQA cancelled, other suppliers identified in the market. Quotation Exercise to be undertaken.

STA-36299-004-LE – Medtronic

Purchase of Intrathecal Drug Delivery Pumps from Medtronic – initially challenged and returned as there was competition in the market, albeit limited. However, after further investigation, the only alternative pump had been withdrawn from sale and the BSi CE Safety Mark has been rescinded, due to a near death incident in Ireland. Preferential terms negotiated for a call-off

arrangement. As a consequence, a 2.5% discount was negotiated resulting in savings of £3,295.00 exc. VAT.

STA-36578-006-JI - WEQAS

Enrolment of POCT Sites in the Welsh External Quality Assurance Scheme (WEQAS) for 2017/18 — enquired with WEQAS as to whether preferential terms were available for a longer term commitment. However, given that this accreditation needs to be undertaken on an annual basis, an annual renewal process needed to be followed accordingly, therefore, there was no scope for a longer term commitment.

STA-36743-008 - BOC

Upgrade of Medical Gas Systems at POWH – Value of works circa: £145K + VAT. As the value exceeded the EU threshold, a Voluntary Transparency (VEAT) Notice was published in the European Journal to support the justification for Single Tender Action. No challenges were received from the market which confirmed that only BOC could undertake the work required.

Estates – Replacement of Fire and Repeater Panes at Cefn Coed Hospital. The request advised that only supplier, Morris Churchfield, could undertake the work as the system was a closed protocol. Following investigation, it was established that this was not a closed protocol therefore a quotation exercise was requested.

Pathology – LIMS Label Requirements. The SQA form had insufficient information to demonstrate the reasons were robust and could be justified therefore the form was returned and more information has been requested.

Richard Wolfe – Replacement Scopes. The SQA form was returned, as there was insufficient information to demonstrate the reasons provided were robust and could be justified. In addition, there were other known suppliers of scopes therefore a quotation exercise is being undertaken.

Requests for annual subscriptions, licences or registrations are reconsidered where it may be more cost effective to extend the contract terms for longer periods, thus reducing the frequency of requests, year on year. Examples are as follows:

ABM-SQA-36792-29-AT - Integra

HB's Equipment Management Database E-Quip. The SQA request was for a one year software licence at a cost of £5450. Agreed with the requisitioner and the provider that a 3 year licence would be purchased at a cost of £16,350.00 resulting in a cost avoidance saving of £329.18

ABM-STA-36868-BM - Zetasafe

Asset management licence used for statutory compliance with water management legislation. The SQA request was for one year licence at a cost of £15,166. Agreed with the requisitioner and the provider that a 3 year licence would be purchased at a cost of £45,498.00, resulting in a cost avoidance saving of £612.71

Alpha Laboratories

Fixed Control Cells need for internal quality control of immunophenotyping by flow cytometry, £6,726.16. Authorised SQA form advises that there are two suppliers able to provide this product, therefore, the form was returned and the requisitioner advised that a quotation exercise needed to be undertaken with the two known and any other suitable suppliers.

5 Recommendations

5.1 The Audit Committee is asked to note the SQA's and STA's approved in the period July to December 2017, the comparison analysis for 2016/17 and 2017/18 to date, the regular STA and SQA requests and the SAT's and SQA's deferred.
