Please see attached our current CCTV policy and accompanying "Body Worn Video" Guidance. Please note that this policy and guidance remain extant until replaced by our new CCTV and Body Cam Footage policies which are currently in draft format and therefore we are unable to provide at this time. This is in line with Section 22 of the Freedom of Information Act which states that information is exempt if it is intended that the information held by the public authority will be published at a future date. I can however inform you that these draft documents should be available by the end of the summer 2026.
