I refer to your Freedom of Information Act Request acknowledged by ourselves on 8<sup>th</sup> May 2019. Your request sought information relating to Amman Tawe Partnership.

**1. What will be the consequences of the Board refusing the request from the Amman Tawe Partnership relocating medical services away from 4, Gwilym Road, Cwmllynfell? What plans does the Board hold for the provision of access to GP services in the locality of Cwmllynfell, should the Board reject the application to stop providing General Medical Services by the Amman Tawe Partnership at a premise in Cwmllynfell?**

General Medical Service (GMS) contractors are responsible for securing their own premises for service delivery. A request from a contractor to close their branch site requires the Health Board to instigate a formal process. If as a result of this process the Health Board determines that this application is refused then the contractor should continue to deliver services from the area.
