**As such we would be grateful if you could provide us with the following information under the Freedom of Information Act, relating to the codes used in your hospital to document this condition and its treatment:**

**Coding relating to diagnosis:**

- **Patellar Dislocation** – S83.0 (Patella Dislocation Congenital – Q74.1)
- **Recurrent Patella Dislocation** – M22.0
- **Patellar Instability** – M23.5

**Coding relating to treatment:**

- **Lateral Release** – W78.3
- **Trochleoplasty** - W77.5 & Z76.5
- **Tibial Tubercle Osteotomy including Elmslie Trillat** - W77.5 and / or W77.2
- **Tibial Tubercle Osteotomy including Maquet** - W77.5 and T70.3
- **Medial Patello-Femoral Ligament (MPFL) Reconstruction** - O27.1 or W74.3 & Z77.4 / Z84.6
