Adult Formulary for the prescribing of Urinary Catheters, Incontinence Appliances, Drainage Systems & Accessories

Introduction

This formulary has been prepared by the Community Continence Team and approved by The Heads of Community Nursing and Medicines Management. The products included have been chosen by consensus and are based upon clinical experience, clinical effectiveness, patient requirement and cost effectiveness. Costs are current drug tariff prices (January 2020) for primary care only, these are subject to change.

It aims to reduce harm; variation and waste by simplifying the prescribing of urinary catheters, incontinence appliances, drainage systems & accessories. The formulary will be updated annually to reflect current best practice and clinical innovation in newly marketed products in order to maintain high quality and up to date choices.

The formulary is available to all health care professionals prescribing and/or obtaining urinary catheters and continence care medical devices for general adult use across the SBUHB footprint.

The Formulary should be used alongside SBUHB's Catheterisation Policy (accessible via SBUHB Intranet).

Individual patient assessment is essential. It should be remembered that the use of any continence appliance can significantly affect patients and carers, physically, socially, psychologically and sexually. These issues should be taken into consideration whenever an appropriate product is prescribed.

Patients and carers should be given the opportunity to make an informed choice when selecting products. The choice however, is determined by clinical assessment and is guided by the Continence formulary.

Any non formulary products require approval by the Community Continence CNS/Continence Nurse Assessor on an individual's clinical needs. Where ever an alternative product is required an exception form should be completed by the assessing professional.

It is important that a regular review of the patients individual needs is reviewed, as often new products become available which may meet the patients or carers needs more appropriately.

Catheter maintenance solutions should only be used where clinically indicated and supported by local standard policy/procedure.

Rationale for use, indication of proposed duration of regime and a review date should be documented. **Catheter maintenance solutions should not be**

used to 'unblock' a blocked catheter due to risk of Catheter associated urinary tract infection (CAUTI). Blocked catheters should be replaced.

Each patient should keep three spare catheters in stock to ensure adequate supplies of medical devices are maintained and replaced accordingly.

All continence products are classified as medical devices and are regulated by the Medicines and Healthcare Products Regulatory Agency (MHRA). The MHRA should be informed of minor faults and discrepancies between products as per SBUUHB Policy.

The Continence Team offer independent training and advice.

SBUHB are proud of the Continence Prescription Service it provides for the population where individual choice of the patient is taken into account.
