Dear [REDACTED],

I refer to your Freedom of Information Act Request acknowledged by ourselves on 5th January 2021. Your request sought information relating to deaths from COVID-19.

- 1. How many people have died in your hospitals from Covid 19 alone? As in they died only due to Covid 19. I can see the figures that you publish online, but these are deaths within 28 days of a positive covid test, so they could have died from other causes. I just want to know the exact figure from 1st February 2020 until the 20th December 2020 of people that have died due to Covid-19 Alone and no other medical problems please.**

I can confirm that the information you are seeking is held on our Disclosure Log on our website. Under Section 21 of the Freedom of Information Act (information accessible by other means), we are not required to provide information in response to a request if the information is already reasonably accessible to you. May I therefore recommend that you look at this link to our disclosure log, which contains details of where you can obtain the information you require:

- 2. I would also like a copy of the documentation paper of the Isolation from the Covid-19 Virus.**

You clarified on 5th January 2021 that you are looking for "any evidence you have of the isolation of the covid-19 Virus on record. For there to be a Virus, it has to be isolated and you should have record showing this"
