I refer to your Freedom of Information Act Request acknowledged by ourselves on 10th March 2020. Your request sought information relating to migraines. You clarified on 26th March 2020 that you would like information for both our migraine clinics and inpatients/day attenders.

Please note that the information provided is for calendar year 2019.

1. Does the hospital/hospitals treat chronic migraine?

Yes – there are 3 regular headache clinics. One in Neath Port Talbot Hospital and two in Morriston Hospital.

2. Total number of unique patients treated in the last 12 months for migraine (You clarified on 23rd March 2020 that this refers to all migraine patients in general)

We are unable to differentiate between general and chronic migraine on our systems, however the number of unique patients seen as both outpatients and inpatients and in headache clinic in 2019 for all types of migraine was 1046.
