I refer to your Freedom of Information Act Request acknowledged by ourselves on 12th March 2020. Your request sought information relating to a road sign at Singleton Hospital.

There is a sign at the rear entrance to Singleton Hospital. I understand the Health Board has stated that the sign has always read 'turn left' in English with an arrow to depict the intended direction.

On the 12th March you provided a photo of the relevant sign. You stated that you believed that the repainting of the english wording and of the directional arrow was undertaken in 2019 and would like documentation to prove this was the case.

You further clarified on the 9th April stating that you did not believe this was repainted and this was the first ever application of the signage with an arrow and English wording. You require proof that this previously existed, as you believe this is not the case.

I can confirm that the Health Board does not hold the work/invoice documentation specific to the particular sign that you refer to in your request. During October 2019, painting and repainting of signage and road markings was undertaken across the whole site at Singleton Hospital as part of a larger project, however specifics within this documentation does not detail the signage you are referring to in your request.
