I refer to your Freedom of Information Act Request acknowledged by ourselves on 19<sup>th</sup> November 2020. Your request sought information relating to discharges to care homes.

We have followed Welsh Government guidance throughout the course of the pandemic and have adjusted our discharge processes to ensure that we were able to support the discharge of patients out of hospital beds to free up acute care capacity to support the pandemic and to also safeguard vulnerable patients from contracting COVID-19 whilst in hospital. On 22nd April, a letter was received from Welsh Government requesting that all patients being discharged from hospital to a step down or care home setting be tested regardless of whether or not they were admitted to hospital with COVID-19.

**1. How many patients were discharged from Swansea Bay University Health Board hospitals to care homes, between September 1, 2020, and November 1, 2020?**

207 patients

**2. Of those patients discharged, how many were tested for Covid-19 before discharge?**

Please note that 8 of the patients counted above were admitted and discharged on the same day, therefore did not require a test before discharge.

**3. Of those patients who were tested, how many patients' results were:**

- a. Positive** – less than 5
- b. Negative** – this information is withheld
- c. Inconclusive** – none

Where fewer than 5 has been indicated we are unable to provide you with the exact number of patients, as due to the low numbers, there is a potential risk of identifying individuals if this was disclosed. We also cannot provide you with the answer to Q3b as this would enable you to work out the exact number for Q3a. We are therefore withholding this detail under Section 40(2) of the Freedom of Information Act 2000. This information is protected by the General Data Protection Regulation (GDPR) and Data Protection Act 2018 and its disclosure would be contrary to the data protection principles and constitute as unfair and unlawful processing in regard to Articles 5, 6, and 9 of GDPR. This exemption is absolute and therefore there is no requirement to apply the public interest test.
