I refer to your further query dated 8th December 2020 regarding our response to your Freedom of Information Act Request sent to you on 7th December 2020.

You requested that we re-examine the original request, as you have been made aware by PHW and Local Authorities that this should be held by the health board.

You clarified on 9th December 2020 that the information you are looking for relates to the license/rental agreement between Swansea Bay Health Board and the Bay Studios and Llandarcy field hospital sites.

I can confirm that we do not have a license agreement for the Llandarcy site, as this was never used or occupied and was decommissioned during September 2020 with the reinstatement works being completed by the 24th December 2020.

The license for the Bay site has not yet been finalised. However, utilisation of the building is on a "peppercorn" basis – there is no cost involved to the Health Board.
