Thank you for your query received by us on 10th November 2020 regarding our response to your Freedom of Information request, sent to you on the same date.

You further queried;

In relation to the question "And or can you provide details from HR logs of the total disciplinarys for staff accessing health records inappropriately and the sanction issued (if point 2 generates too much work)". I note that information provided has been given from August 2019 only. I do acknowledge the reason provided.

However, I wonder if you could check with the HR department if there is definitely no further data they can provide by other means.

I can confirm that we are not able to provide this information prior to August 2019. Before this point the information was held within a spreadsheet. The limitations of this spreadsheet does not allow us to accurately retrieve the information you have requested. This is one of the key drivers for implementing the new ER Tracker system from August 2019.
