Please note that from 1st April 2019 responsibility for providing healthcare services for people in the Bridgend County Borough Council area transferred from Abertawe Bro Morgannwg University (ABMU) Health Board to Cwm Taf Morgannwg University Health Board. However as this request asks for data prior to 1st April 2019, we have provided the information that ABMU Health Board held which will include Bridgend data.
