Please only provide the following:

<u>Section 1 – "when and where?"</u> Please provide incident date, site location

<u>Section 2 – "what happened?"</u> Please provide all data, as it should be anonymised

<u>Section 3 – "categorisation & grading?"</u> Please provide all data, as should be anonymised

<u>Section 4 5 and 6 – "people involved", "details of reporter" and "incident managed by?"</u> No details as this will be personal data

Our response:

In accordance with the Freedom of Information Act 2000, this letter acts as a Refusal Notice under section 17 of the Act.

We can confirm that the Health Board does not hold the data in a format that would enable us to respond to your request to the level of detail required. The Datix system used in Wales does not follow the same procedure provided in the link above, which is used by an English NHS Trust.

We have estimated that this would significantly exceed the 18 hours limit set down by the FOI Act as the reasonable limit. Section 12 of the FOI Act and The Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulation 2004 provides that we are not obliged to spend in excess of 18 hours in any sixty day period locating, retrieving and identifying information in order to deal with a request for information and therefore we are withholding this information at this time.
